



Call for Board Director Nominations

Under the terms of the Constitution of the Elevating Work Platform Association of New Zealand, nominations are called for two board positions. At the 2020 AGM, board member tenures were staggered and extended to three years:

1. Position one – currently held by Neil Radley of Pro Services Ltd. Neil has indicated he needs to stand down from the board for the balance of his tenure due to personal reasons. The board extends a very warm thank you to Neil for his contribution to the association and board during his tenure.
2. Position two – currently held by Kenny Marshall of Franklin Trees Ltd. Kenny is standing again for this position.

The successful candidates must be willing to serve a term on the EWPANZ board following confirmation of their appointment at the Association AGM, which will be held on the Wednesday 17th February 2021.

The election of Board members shall be conducted as follows:

10.3a: The Chief Executive Officer shall first call for nominations by a specified date. Nominations should be received by the Association not less than twenty-one days (21) before the date of the Annual General Meeting. All nominations shall be signed by at least two (2) financial Members.

10.3b: The Chief Executive Officer shall conduct the election of the Directors in accordance with item 9.6 prior to the Annual General Meeting in sufficient time to ensure that the result of the elections can be announced at the annual general meeting.

10.3c: After determining the results of the elections the successful candidates shall (whether or not they have been previously disclosed) be announced at the annual general meeting, and they shall take office at the conclusion of that meeting.
